

Meeting Minutes:

A pre-bid meeting was held with IT Firms/Companies at 11:30 AM on January 16, 2024, at HRDC-IMSciences.

The meeting was chaired by Sajid Fahim (Project Lead).

The following points were discussed and agreed upon:









Mr. Shakir Ullah, Deputy Director IT, Local Government, Khyber Pakhtunkhwa gave a brief about the scope, overall goals, scalability & objectives of the project. Various queries were asked by the IT firms online & physically. Their queries were answered and clarification thereof was made on the spot details of which is given below.

- 1. Vendors enquired about the IBPMS platform where they were informed that IBPMS is a separate platform which provides information about Development Budget and it planning and Monitoring. The android application is looking for people demand and complaints which will be incorporated with IBPMS to have a comprehensive view about Local Government activities at VC/NC level.
- 2. The vendors were informed that a separate dashboard will be developed for Secretary Local Government, KP where data from the applications will be presented. Similar dashboards will also be required for KP Education and Health departments (Data at PTC and PCMC level will be generated) for the top management of the departments.
- 3. Vendors were informed that the application will be made for Android smartphone and not for I Phones (iOS).
- 4. The Vendors were informed that the source code of already developed android application will be provided to the successful bidder.
- 5. The item Sr. No. A, 1 under Technical Evaluation Criteria (Annexure II) be read as Number of Years a Firm is Established (1 Mark for each year beyond 10 years mandatory requirement).
- 6. The vendors were informed that under point 2 of the TORs the requisite previous experience in collaboration with the Local Government Department is 2 years.
- 7. Vendors were informed that the firm will provide 6 months free support to the Local Government department.
- 8. Digital Application to be developed will have both Urdu and English as language.
- 9. For determining the Financial Capabilities (Technical Evaluation Criteria) the Average Annual turnover of the last 3 years (instead of 5 years) will be considered.
